# Handicapping Contest Rules 2025

- \$100 entry fee, \$100 Tournament Bankroll, limit 2 entries per player (\$200 due at sign-up, limit 2 entries per person.)

*\$70 out of each entry fee will go to the prize pool, and \$30 will go towards the cost of entering winners into the September Qualifying Contest at Legacy Downs and Horsemen's Park (Date TBD) and, ultimately, the cost of the 2025 Del Mar Fall Challenge Handicap entry and travel costs.*

- Win, Place, Show, and Exacta Wagering only. **You must wager at least \$100 during the contest AND wager on a minimum of 6 races before 6:00pm.**
- Wagers other than Win, Place, Show, and Exacta will result in immediate disqualification from the contest.
- You will be provided with a list of eligible tracks and races that you may wager during the handicapping contest. **ONLY THESE TRACKS AND RACES MAY BE WAGERED DURING THE CONTEST.**
- The contest will conclude at 6:00pm. Any wagers placed at tracks or on races not included in the eligible tracks and wagers list provided to you are subject to immediate disqualification from the handicapping contest.
- To win the tournament, build your bankroll as high as possible. There is no minimum wager amount! Use your winnings to increase your wagers and, in turn, your bankroll! The top 5 players with the highest bankrolls at the end of the contest will make the money!
- If your horse is scratched, you can cancel or change your wager before the race closes. If you fail to get your ticket canceled in time, wagers involving the scratched runner will be refunded to your contest account. **YOU WILL NOT be given the Post Time Favorite.**
- Any money remaining on your contest card can be cashed out at the end of the contest. All Contest transactions will be made with your issued contest card and contest account at any self-service terminal or on the Mbet mobile platform. Mutuel personnel must verify all transactions before declaring the top 5 finalists "Official". No additional deposits and/or withdrawals may be made until the contest is over and the winners declared "Official". **Any deposits/withdrawals made during the contest will result in immediate disqualification.** Tie breakers will be determined by the player who wagered the most money throughout the course of the tournament.
- Must be at least 21 years of age on the contest date to play. A valid I.D. will be required to play and for prize verification.
- In the instance that you need to cancel your contest entry, please notify the Mutuel Manager as soon as possible. **Entry fees will be non-refundable beginning Friday, February 21<sup>st</sup>, 2025 @ 7:00pm.**

Pick up your entry form at the Mutuel Teller Line. Sign-up begins Monday, February 17<sup>th</sup>, 2025 @ 10:30am and closes Saturday, February 22<sup>nd</sup>, 2025 @ 1:30pm

# Payouts

(Tie breakers will go to the player who wagered the most money throughout the course of the contest)
